



Dog Training Services Agreement

This Agreement between _____

Services: I understand that dog training includes learning and reinforcing the Palm Springs Dog Training methods, terminology and techniques in private sessions and day training programs. Trainer will make every reasonable effort to help Client achieve training and behavior modification goals but makes no guarantee of Dog's performance or behavior as a result of providing professional animal behavior consultation. Client understands

that he/she and members of the household must follow Trainer's instructions without modification, work with dog daily as recommended, and constantly reinforce training being given to Dog.

Cancellation Policy: If Client fails to give at least 24 hours cancellation notice, or is not present at time of scheduled appointment, session fees are still due. For a package deal, the session will still be counted as one session. I understand that training packages are not transferrable to any other dog or party not listed on contract.

Refund Policy: Palm Springs Dog Training holds a no refund policy as a standard policy for all clients. No exceptions. This no-refund policy is effective for both Day Training and Private class training packages. Palm Springs Dog Training reserves the right to change the pricing structure on any and all curriculum without obligation to refund existing registrants of those sessions.

Termination: Palm Springs Dog Training reserves the right to terminate the training contract at any time before or during its term if Trainer determines that a danger exists to the health and safety of the

public, Trainer, owner or dog. Should the Trainer or Owner terminate the training contract at any time prior to completion, all fees are non-refundable and non-transferable.

Contracts for on-going training are automatically terminated if we do not hear from the client for a period of 90 days. After 90 days, on-going training contract will cease. No refund will be issued for any lessons remaining on contract.

Credit Card Policy: A 5% processing fee will be applied to all credit card payments.

Late Policy/Day Training: If client is not present at the time of scheduled pick-up, an additional \$35.00 will be added for every 15 minutes past scheduled pick-up time.

Health Policy: With approval, we accept healthy, fully vaccinated dogs and puppies. We require all dog owners to follow this protocol:

1. Completed a series of standard vaccines and current boosters.
2. Up-to-date rabies vaccine.

3. Recent de-worming.

4. Vaccine for bordetella bacterium and regular boosters.

Social Media Consent: I hereby authorize Palm Springs Dog Training, to use my dogs photo and/or video relating to my dogs training experience, on social media for advertising purposes. I release them from any and all liability which may arise.

Liability: If Dog causes property damage, or bites or injures any dog, animal or person (including but not limited to Trainer), during or after the term of this Agreement, then Client agrees to pay all resulting losses and damages suffered or incurred, and to defend and indemnify Trainer and Trainer's agents from any resulting claims, demands, lawsuits, losses, costs or expenses, including attorney fees. If Dog is injured in a fight or in any other manner during or after the term of the Agreement, Client assumes the risk and agrees that

Trainer should not be held responsible for any resulting injuries, losses, damages, costs or expenses.

At Trainer's sole election, Trainer's duties hereunder shall terminate if (a) in Trainer's sole judgment Dog is dangerous or vicious to Trainer or any other person or animal, or interferes with the training of other dogs, or (b) Client breaches any term or condition of this Agreement. Upon termination in accordance with the foregoing, Trainer's duties shall terminate but all other provisions of this Agreement shall continue in full force and effect.

This Agreement is binding upon Client, spouse of Client, and children of Client. This Agreement supersedes all prior discussions, representations, warranties and agreements of the parties, and expresses the entire agreement between Client and Trainer regarding the matters described above.

The parties confirm that, except for that which is specifically written in this Agreement, no promises, representations or oral understandings have been made with regard to Dog or anything

else. Without limiting the generality of the foregoing, Client acknowledges that Trainer has not represented, promised, guaranteed or warranted that Dog will never bite, that Dog will not be dangerous or vicious in the future, that Dog will not exhibit other behavioral problems, or that the results of the training will last for any particular amount of time.
